Berg provided an update on existing funding agreements, noting active lowa Great Places grants. Berg also discussed future opportunities for community development funding and engagement and expressed his gratitude to the Board.

#### **Board Update**

Determan expressed pride in the Board's accomplishments both large and small and thanked Berg and the rest of the staff for their work. Determan expressed a desire to continue helping communities, making lowa a great place to live.

#### **Board Discussion**

Determan opened the discussion. Burnett expressed concern with increased costs for development.

Durham expressed hope that more funding will become available with recent tax changes. Burnett asked whether Hotel/Motel tax could be used to support creative placemaking. Durham said there have been discussions, and there is interest from other groups such as the tourism industry. Schmitz said the staff will update Board members about any changes from the legislature.
